The carbon fiber provides the garment with high durability and strength, along with antistatic properties. The functional pocket lines integrated into the seams eliminate material layering, featuring a design without visible zippers and a concealed waistband button. The shorts are equipped with two front slash pockets and two back pockets. The rear part is shaped with a yoke, and the elastic waistband allows for waist adjustment to fit various body types. The carefully crafted, anatomically shaped 3D Silhouette cut COMFORT FIT ensures a comfortable fit. Enhanced user visibility is provided by reflective strips on both the front and back sections. The garment contains no metal accessories and is designed for industrial laundering. Compatible with the ARDON® REFIWAN® ID card.

The ARDON®REFIWAN® shorts do not meet the requirements of EN 1149-5 and EN 61340-5-1 standards. They offer only basic protection against dust and surface-level mechanical effects and are therefore classified as Category I personal protective equipment.
